Frequently Asked Questions

The following questions and answers should be read in conjunction with the Registration Statement on Form S-1 available on the Investors tab at www.rivieraresourcesinc.com.

I have a contract with Linn Operating. Will it be assigned to Riviera?

Any contracts with Linn Operating, LLC (f/k/a Linn Operating, Inc.) remain with Riviera Operating, LLC with no action required on the part of either party. At the subsidiary level the only legal change was the name change from Linn Operating, LLC to Riviera Operating, LLC.

I have a contract with Linn Energy Holdings. Will it be assigned to Riviera?

Any contracts with Linn Energy Holdings, LLC remain with Riviera Upstream, LLC with no action required on the part of either party. At the subsidiary level the only legal change was the name change from Linn Energy Holdings, LLC to Riviera Upstream, LLC.

I have a bond or letter of credit from Linn Operating or Linn Energy Holdings. How do I get a new one?

At the subsidiary level the only legal change was the name change from Linn Operating, LLC to Riviera Operating, LLC or Linn Energy Holdings, LLC to Riviera Upstream, LLC, so existing bonds and letters of credit are still valid. We will order replacement bonds and send them to you in the ordinary course of business. If you are in urgent need of a replacement bond, please contact Legal@RVRAresources.com to expedite your update. Letters of credit with Linn Operating or Linn Energy Holdings remain binding on Riviera Operating or Riviera Upstream respectively as there was no change at the subsidiary level other than a name change.

What is the relationship between Blue Mountain Midstream and Riviera?

Blue Mountain Midstream LLC is a wholly-owned subsidiary of Riviera Resources, Inc. Blue Mountain is operated by Riviera Operating, LLC as its agent. If you need a copy of this agreement, please contact Legal@RVRAresources.com.

I have a contract with Blue Mountain Midstream. Was that entity impacted?

Other than a change in its ownership structure, Blue Mountain Midstream was not impacted by the events described in this letter. The ownership change did result in an update to Blue Mountain Midstream's W-9, which is available on the Riviera Website under the Owner Relations tab by clicking "Riviera Name Change." Riviera Operating, LLC will continue to pay invoices on Blue Mountains behalf.
